Ms. Shabnam Siddiqui, Director, CEGET was elected as Vice Chair Advisory Group of Alliance for Integrity, India (AfIn).

The Alliance for Integrity is a business-driven, multi-stakeholder initiative seeking to promote transparency and integrity in the economic system. To achieve this goal, it fosters collective action of all relevant actors from the private sector, the public sector and civil society.

The Alliance for Integrity is a platform that offers practical solutions to strengthen the compliance capacities of companies and their supply chains. In addition, the Alliance for Integrity contributes to the improvement of framework conditions by fostering dialogue between the public and private sectors.

It is the only business-driven, global multi-stakeholder initiative initiated by the German Federal Ministry for Economic Cooperation and Development (BMZ), the Federation of German Industries (BDI) and the German Global Compact Network and is implemented by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH.

Currently AfIN operates out of Germany, India, Indonesia, Mexico, Paraguay, Uruguay, Colombia, Ecuador, Chile, Brazil, Argentina, and Ghana.

Global Compact and AfIN Networks have strong connections and crossovers in all countries of operation.

Anti-Corruption Collective Action Playbook

To enhance the knowledge, understanding and capacity of Local Networks on Anti-Corruption Collective Action, the United Nations Global Compact, is developing an Anticorruption Collective Action Playbook, to mainstream the understanding and uptake of Collective Action. The definition of Collective Action that the playbook will focus on is "Collective action is a collaborative and sustained process of cooperation between stakeholders.

It increases the impact and credibility of individual action, brings vulnerable individual players into an alliance of like-minded organizations and levels the playing field between competitors. Collective action can complement or temporarily substitute for and strengthen weak local laws and anti-corruption practices.”

The Playbook will include Collective Action Initiatives sought through multi-stakeholder dialogues, and have guidelines on formation of advisory group, reporting, training tools and extensive strategies for private sector involvement in aligning mutual interests, challenges & collective vision of the Networks.

CEGET has participated in two of the Consultations on the Playbook and looks forward to sharing it with their stakeholders towards the end of 2020.

This initiative is part of the Siemens Integrity Initiative Third Funding Round Project, being implemented by UNGC.

The Integri-TEA Series with Women Entrepreneurs: Promoting Prevention of Corruption and Improving Business Integrity



Alliance for Integrity (AfIN) has organized **Integri-Tea** sessions with women entrepreneurs of Assam, Manipur, Nagaland, and Mizoram in May-June 2020.

In this session Afin facilitates informal conversations with women entrepreneurs and tries to provide them a comfort and trust zone to discuss issues related to compliances.

Depending on need, a follow up specific session on contract management, IPR, GST, would be conducted. The overall outcome of these sessions will focus on networking and capacity building.

Similar sessions have been planned in Argentina, Brazil, Ghana and Indonesia, the idea being that the women entrepreneurs of the world unite.
