UNGC Regional Meeting Session on Anti-Corruption

Business has a critical role to play to fully embed and deepen the Ten Principles and to take ambitious action to deliver on the SDGs as an essential part of building back better. Over the last decade, UNGC Local Networks have been mobilizing business on the 10th Principle through Collective Action to advance the fight against corruption and the achievement of the SDGs, particularly Goal 16 (target 16.5).

At the UNGC Regional meeting of the Asia Pacific, a session on Anti-Corruption has been organised on June 30, 2020 (11:00 am to 12:00 pm EST) as a lead up to the UN General Assembly Special Session (UNGASS) against Corruption 2021. This Regional Meeting Session will be more imperative for business to join forces with governments, community-based organizations, NGOs, and other stakeholders to act collectively against corruption. In this session, current Anti-Corruption Collective Action activities both at HQ and within the Local Networks level, along with opportunities for Local Networks to start engaging in the preparatory process for UNGASS 2021 are going to be discussed.

CEGET at Global Compact Network India, being the partner of UNGC for implementing Scaling up Anti-Corruption Collective Action, will present its work on Anti-Corruption Collection Action and the relevant challenges in India.

Scaling up Anti-Corruption Collective Action within Global Compact Local Networks

Under the aegis of the recently launched UNGC project ‘Scaling up AntiCorruption Collective Action within Global Compact Local Networks’ UNGC is working on the development of an Anti-corruption Collective Action Playbook, in consultation with multiple local networks. The detailing of the playbook is complete and we hope to launch the playbook in Fall 2020.

Additionally the 1st kick-off Call was held between UNGC and the Partner Local Networks (India, Brazil, Ukraine and Kenya) wherein the UNGC senior management team comprising of Lila Karbassi, Chief of Programmes; Olajobi Makinwa, Chief of Intergovernmental Relations & Africa; Ole Lund Hansen, Chief of Global Operations and Ms. Ashley, Project Manager presented an overview of the project and detailed out the process and expectations. Mr. Somnath Singh, Programme Manager and Mr. Aryadev, Programme Analyst represented Global Compact Network, India in this call.

The 2019–20 coronavirus pandemic has affected educational systems worldwide, leading to the near-total closures of schools, universities, and colleges. Like many countries in the world, India followed the path of Lockdown leading to the closure of primary, secondary, and tertiary schooling which leads to cancellation of exams, deferring admission entrance, etc to stem the spread of COVID-19 through non-pharmaceutical interventions and preventive measures such as social-distancing and self-isolation. As the days pass by with no immediate solution to stop the outbreak of Covid-19, school and university closures will not only have a short-term impact on the continuity of learning for more than 285 million young learners in India but also engender far-reaching economic and societal consequences.

The objective is to understand the impact of the COVID and bring out the best and most innovative ideas and solutions to the ground by the future entrepreneurs and budding managers. It will also provide an opportunity to showcase one's leadership skills among the students and faculty along with a creative Professional Prowess. Besides, the competition will enable the students to represent their expectations for the situation post-COVID-19.

Recognizing this imperative, under Principles for Responsible Management Education ([PRME](#)), GCNI is organizing Manthan 2020 on the theme 'Responsible Management Education in a Post COVID World: Emerging Innovative practices in Management Schools'. "Towards Resurgent India:
Aligning Business with Sustainable Development Goals"



This year's **UN Global Compact Leaders' Summit** marked 20 years of uniting business for a better world. The event was curated virtually on 15–16 June 2020, and was bigger, better, and more inclusive than any physical event held so far. The high-level programme literally 'chased the sun' as it went on for 26 hours so that Global Compact Local Networks members and supporters from every time zone could participate. The event witnessed the launch of a special report that explores 20 years of corporate sustainability data and provides key findings on business integration of the Ten Principles and action to deliver SDGs. The conclusion of the Summit heralded new beginnings at UNGC with Ms. Sanda Ojiambo, a Kenyan business leader, taking over the mantle of leadership on June 17, 2020. Ms. Ojiambo, served as Head of Sustainable Business and Social Impact at Safaricom PLC, in Kenya, since 2010, and as Senior Manager of the Safaricom and MPESA Foundations from 2008 until 2010, during which time she led the implementation of several public-private partnership initiatives between Safaricom and United Nations entities. In her welcome address Ms. Sanda Ojiambo, ED & CEO, UNGC, highlighted the following points:

- ✚ Companies participating in UNGC have been able to provide innovation, technology, scale, and impact that are accelerating progress towards the 2030 agenda and its 17 SDGs.
- ✚ While COVID 19 has created and unprecedented crises, Climate-change and growing inequality continue to shake the very foundation of business and humanity, and this is where the 10 principles of UNGC continue to provide strong pathway for business.

- ✚ Now more than ever business should provide a central role in societal transformation. “The business of Business can no longer Business.
- ✚ There are significant challenges that define our world today-from declining trust to growing inequalities to fragile trade networks and broken supply chains to weakening international corporation and weakened social cohesion. Each of these challenges present an immense opportunity for business to reinvent, therein also lies the opportunity for stronger partnerships.
- ✚ As the UNGC enters the next phase, it will be essential to keep strengthening the local networks as key pillars of the initiative and continue to build mutually reinforcing partnerships with government, the UN and other key stakeholders.
- ✚ Local Networks are an integral building block and cornerstone of UNGC work. They help local business understand what responsible business means within different national, cultural and language contexts by facilitating outreach, learning, policy dialogue, collective action, and partnerships. The networks are regional, multi-stakeholder, inclusive, action-oriented, and strong action platforms for networking with sustainability leaders and influences.

Ms. Ojiambo concluded her address by reiterating that since its inception, the Global Compact has advanced the vision that when businesses unite, they can be a powerful force for good. In this unprecedented time of global uncertainty and crises, that vision has never been more important.
