### ***UNGASS 2021: United Against Corruption***



Centre of Excellence for Governance, Ethics and Transparency (CEGET) at Global Compact Network India (GCNI) stands committed to the fight against corruption and enhance transparency and accountability among the key stakeholders from across sectors.

The UNGASS 2021 (UN General Assembly Special Session) will deliberate on challenges and measures to prevent and combat corruption and strengthen international cooperation. The special session shall adopt a concise and action-oriented political declaration, agreed upon in advance by consensus through intergovernmental negotiations, under the auspices of the Conference of the States Parties to the United Nations Convention against Corruption.

The special accreditation process to attend UNGASS 2021 for the interested representatives of private sector, civil society organizations and academic institutions will close on April 4, 2021. CEGET encourages its members and supporters to register for this international platform against corruption at the earliest.

### ***Scaling up Anti-Corruption Collective Action within Global Compact Local Networks***

Global Compact Network India (GCNI) continued to effectively serve as a Project Local Network (LN) under the UN Global Compact (UNGC) project 'Scaling-up Anti-Corruption Collective Action within Global Compact Local Networks.'

During March 2021, GCNI had a one-to-one meeting with the UNGC Project Manager, Ashley Demming, wherein GCNI shared its ongoing efforts to achieve its project goal. Dr. Somnath Singh, Programme Manager, and Mr. Arya Dev, Programme Analyst, shared that GCNI is planning to form an ACCA working group for their initiative and GCNI has started coordination and virtual interactions with the potential stakeholders from different sectors. Ms. Demming appreciated the initiative and supported the formation of ACCA working group.

With the purpose of sharing project achievements, initiatives and innovations in different project countries, Ms. Demming organized a Project LN group meeting among Project LN Coordinators from India, Brazil, Kenya and Ukraine on 2<sup>nd</sup> March 2021. During the meeting, upcoming activities and events were discussed and Project LN Coordinators shared their achievements.

In addition, the UNGC Anti-Corruption Collective Action Working Group met on 23<sup>rd</sup> March 2021. The meeting focused on the status of the ACCA playbook and its launch, along with receiving feedback on the revised Playbook. The Playbook is tentatively scheduled to be launched at the UNGC Leaders Summit in June 2021. During the meeting, Dr. Somnath Singh and Ms. Ana Luiza Aranha from Global Compact Network Brazil shared that they were both selected as Knowledge Partners for the 2021 OECD Global Anti-Corruption & Integrity Forum. Their sessions both took place on 25<sup>th</sup> March 2021.

**Knowledge Partner: Global Compact Network India**

Global Compact Network India (GCNI) as knowledge partner with 2021 OECD Anti-Corruption and Integrity Forum conducted a session on “Collective Action to fight healthcare corruption post Covid” on 25<sup>th</sup> March 2021. This forum discussed the challenges and the opportunities for strengthening and restoring integrity, responsible business conduct, and anti-corruption efforts in the ongoing context of COVID-19.

The session began with a welcome address to the speakers and audiences by Dr. Somnath Singh, Programme Manager, GCNI. Further he outlined the achievements of GCNI in last decade on Anti-Corruption Collective Action Initiative. He shared about the major initiatives of GCNI that it had taken during different projects like Collective Action Project (CAP) with the UN Global Compact (UNGC); the Anti-Corruption Project with UK Prosperity Fund and Centre of Excellence for Strengthening Transparency and Ethics in Business: Scaling up the Collective Action Agenda in India (Siemens Integrity Initiative) . He shared that with these projects GCNI could...

- provide a platform for anti-corruption dialogue to public and private sector businesses and incentivizes their ethical behavior, develop business case for transparency and take up pressing corruption issues in Indian context; viz. public procurement, bribery and fraud in the private sector and supply chain transparency.
- promote the relevance of Integrity Pact among public and private sector in India.
- promote Governance and Ethics in Businesses by establishing a robust framework of governance and transparency in smart city development in India and also provide an advisory service to Pune Smart City (PSCDCL) on its compliance, accountability and public- private partnership framework etc.

Moving ahead, Dr. Somnath Singh shared that GCNI is a Project Local Network under the UNGC Project "Scaling Up Anti-Corruption Collective Action within Global Compact Local Networks." Under this project, GCNI is developing a local AC collective action initiative in the healthcare sector.

Ms. Ashley Demming, Manager (Anti-Corruption) at UNGC spoke about the UNGC Project and briefly shared information on the upcoming launch of the UNGC ACCA Playbook.

Further the panel discussion took place and the eminent speakers from different sectors shared their knowledge and insights on the need of ACCA to strengthen healthcare sector post covid.

**The panel focused on:**

1. Reviewing and examining the existing corruption challenges in healthcare and pharmaceuticals sector; as experienced during COVID-19
2. Discussing the role of collective action in minimizing corruption risks in healthcare value-chains.
3. Sharing the importance of technology related innovations for fighting emergency response corruption in healthcare. And
4. Emphasizing on regional issues in dealing with healthcare sector corruption.
