### LN Knowledge Sharing Meet towards ACCA Working Group Formation and Engagement



Dr. Somnath Singh, Programme Manager and Mr. Arya Dev, Program Analyst (Legal) at Global Compact Network India (GCNI) had a virtual Knowledge Sharing Meeting with Ms. Ana Aranha, Advisor and Focal point for Anti-Corruption at LN Brazil on 21st May, 2021 to discuss the constitution and governance of an issue-specific Working Group, as CEGET at GCNI is planning to take steps in that direction to drive its collective action initiative through an active and engaged ACCA Working Group.

It was learnt that LN Brazil has many Working Groups which are called Action Platforms, including one on Anti-corruption. It mainly includes participants from private sector but also has participants from the public sector and CSOs, who are carrying forward the ACCA mandate through various activities and commitments. The platform is supported and guided by an advisory committee of 20 members that oversees all of their Collective Action initiatives. GCNI plans to have more meetings and engagements with other LNs to gather thoughts and best practices in future.

Business action to support climate will remain key to enable India to step up its ambition on its NDCs and align with a trajectory of 1.5°C. Engagement with Indian companies is critical to setting India on this ambitious decarbonisation path. "India will not only meet its climate commitments but is set to overachieve it", said Prime Minister Modi Nov 2020 at the G20 Summit. Earlier that month, Prakash Javadekar, the Minister of Environment, Forest, and Climate said that India is on the way to achieve its commitment under the Paris Agreement. The same month, MOEFCC rallied 24 companies to make a signed declaration, recognizing the industry's commitment and urging them for more action on climate change.

The India's road to COP26 Summit is a key moment for Indian businesses to demonstrate their commitment and ambition to drive climate action on clean energy, industry, and transport systems in the lead-up to COP26.

At the opening ceremony of the 1st event of **India's Road to COP26 Summit: Business and climate action**, Welcome address was given by Dr. Divya Sharma, India Executive Director, Climate Group and Dr. Rahul Walawalkar, President and Managing Director, Customized Energy Solutions India Pvt. The Annual Local Network Forum (ALNF) is an initiative of United Nations Global Compact (UNGC) to explore how Local Networks can play a leading role in facilitating private sector engagement on the SDGs and Ten principles. Bringing together 100 Local Networks and Representatives from around the globe, participants discuss subjects related to networks governance and activities and other initiatives

ALNF 2021 took place virtually on 25-27 May 2021 and it has served as the culmination of the Strategy Working Group process. All the Local Network staff, across geographies and timelines shared their insights to achieve the objectives/goals of ALNF 2021. The entire team of GCNI attended sessions throughout the event (25-27 May 2021) and shared its work and achievements on different accelerators of SDGs and Ten Principles of United Nations. ALNF 2021 was full of learning on strategic planning, implementation and growth of local networks including UNGC and associated sectors/members.

## **UNGASS 2021: United Against Corruption**



On 17 December 2018, the General Assembly adopted resolution 73/191( <https://undocs.org/en/A/RES/73/191> ) entitled “Special Session of the General Assembly against Corruption”, in which it decided to convene in the first half of 2021 a special session on challenges and measures to prevent and combat corruption and strengthen international cooperation.

In that resolution, the Assembly also decided that, at that special session, it shall adopt a concise and action-oriented political declaration, agreed upon in advance by consensus through intergovernmental negotiations under the auspices of the Conference of the States Parties to the United Nations Convention against Corruption.

The UNGASS 2021 (UN General Assembly Special Session) will deliberate on challenges and measures to prevent and combat corruption and strengthen international cooperation. The special session shall adopt a concise and action-oriented political declaration, agreed upon in advance by consensus through intergovernmental negotiations, under the auspices of the Conference of the States Parties to the United Nations Convention against Corruption.

***Launch of Anti-Corruption Collective Action Playbook and high-level panel discussion***



The UN Global Compact 2021 Leaders Summit will elevate ambition for strategic collective action, with focused objectives and clear paths to recovery from the continued climate crisis, global pandemic, economic disparities and social inequalities. The annual Summit will once again virtually convene more than 25,000 leaders from business, Government, the UN, and Civil Society, to take stock of the state of progress, highlight the areas for greater influence, and drive collective action on focused issues to make lasting change. Only through multi-stakeholder collaboration, innovative thought leadership, transparent reporting on progress and focused data driven initiatives can we get back on track. Now, more than ever before, adherence to the Ten Principles and advancement of responsible business practices is essential for recovery and rebuilding a just, equitable and resilient society.

Recognizing the importance of collective action, the UN Global Compact, in collaboration with Global Compact Local Networks and partner organizations including India (GCNI), has been implementing Collective Action initiatives for over a decade. Most recently in December 2019, the UN Global Compact launched a multi-year project, **“Scaling Up Anti-Corruption Collective Action within Global Compact Local Networks”** to support initiatives from the Global Compact Local Networks / Partners (LN India, Ukraine, Brazil and Kenya) and promote public-private cooperation in fighting corruption. As one of the major project activities, an Anti-Corruption Collective Action Playbook has been developed to mainstream the understanding and uptake of Collective Action among Global Compact Local Networks, business and other relevant stakeholders.

UN Global Compact Leaders Summit plenary will feature the launch of the Anti-Corruption Collective Action Playbook and a high-level panel to discuss the impact of Collective Action in the fight against corruption, success factors in public-private engagement and emerging trends in Collective Action on June 2021.
